About AEMI Knowledge Centre And Training Programme

The AEMI Knowledge Centre and Training Programme (KCT or Knowledge Centre) is a project under the African Energy and Mining Management Initiative (AEMI).

The AEMI Knowledge Centre provides a platform where key issues in African energy and mining are addressed through fieldwork studies, research, trainings capacity building. The aim of Knowledge centre is to apply abundance of energy and mining experiences accumulated within AEMI in a practical and useful manner. In this respect, under the auspices of the Knowledge Centre, AEMI shares fieldwork reports and research papers focusing on energy and mining in Africa; educational videos; capacity building through trainings and workshops; legal aid project aimed at not only providing legal services to miners but also educating lawyers about the key issues in energy and mining. Moreover, under the auspices of the Knowledge Centre, AEMI also reaches out to local communities by offering trainings to interested people; primary schools; and secondary schools. AEMI outreach to educational institutions such as schools enables AEMI experts and members to offer mentorships to the youth who are interested in energy and mining. AEMI collaborates with various stakeholders including international organisations: NGOs; the private sector; universities; and government institutions to achieve the objectives with respect common knowledge sharing in the energy and mining sectors.

ENERGY & MINING EXECUTIVE MASTERCLASS TRAININGS

We offer courses to professionals interested in energy and mining. On a successful completion of the course, certificates of participation are provided by AEMI. These courses are suitable for a wide range of audiences including lawyers, engineers, economists, accountants and other professionals with an interest in energy and mining. Additionally, through our fieldwork activities, we also train non-professionals including the local communities about the key issues in energy and mining.

AEMI courses and programmes provide professionals and practitioners with practical educational courses that allow individuals to supplement their knowledge and experience with up-to-date academic and practical thinking in an interesting, challenging and interactive learning environment that combines theory, practice and the experience of participants. Some of the courses and trainings provided by the AEMI Knowledge Centre are briefly described below:

1. The role of Oil & Gas in African energy security

Energy is key in the economic development of different African countries. However. many countries still struggle with energy challenges including low electrification rates; reliance on traditional energy including firewood and charcoal; lack of energy infrastructure just to mention but a few. Additionally, many people in Africa have no access to electricity and these are mostly found in rural areas. Appreciating the importance of this subject matter, AEMI under the auspices of the Knowledge Centre offers trainings focused on understanding the oil and gas sector and its role in meeting the African energy challenges. In this two days training, participants will acquire knowledge in the oil and gas sector with respect to: acquisition of and divesting

of ownership and production rights; oil & gas agreements including production sharing contracts, licences/concessions and joint operating agreements. Participants will also acquire immense knowledge and understanding of the oil & gas value chain including exploration, development, extraction, transportation, manufacturing and marketing.

2. Training on renewable energy and transition to a low carbon economy

This 2 days training explores on the key developments in the renewable energy sector. Participants will have an understanding of the different types of renewable energy; advantages and disadvantages of renewable energy; national initiatives in the development of renewables; regional and international initiatives in renewable energy projects. The training also will also explore on issues related to energy transition with a focus on transitioning to a low carbon economy. Participants will acquire immense knowledge about the evolution of energy transition in both developing and developed countries; the investment opportunities presented by energy transition; and the challenges and barriers of transitioning to a low carbon economy in Africa.

3. Technologies in renewable energy

This two days training explores the technologies and developments in low carbon energy including electric vehicles; smart grids; smart meters; energy efficiency and energy storage. Participants will gain an understanding of the energy efficiency projects and initiatives at both national and regional level. Through a comparative analysis, participants will acquire knowledge of the global developments in electric vehicles, smart grids, and smart meters and the opportunities these technologies present in the 21st century in both developing and developed countries.

4. Training on international energy law and policy

This one day training offers participants with an understanding of international energy law and policy. After a successful completion of this training, participants will be aware of oil and gas laws; renewable energy laws; and environmental laws related to the energy sector. Additionally, participants will acquire knowledge in national; regional and international energy laws and the relevant institutions in the management and governance of the energy sector.

5. Training on Justice issues in the energy sector

This one day training will give participants an understanding of energy Justice; environmental justice and a just transition to a low carbon economy. Participants will acquire knowledge with respect to the injustices and inequalities in the energy sector as experienced in developing and developed countries and the solutions to such injustices.

6. Energy project finance

This 2 days course introduces the participants to project finance in both oil & gas and renewable energy. After this intensive course, participants will be confident in topics relating to equity financing; project financing; corporate financing and the key risks involved in financing oil & gas projects on one part and renewable energy projects on the other hand.

7. Local Content in the Energy Sector

Local Content is a pivotal topic of the 21st century in the energy sector. This 2 days course introduces participants to the definition of local content; various ways countries are involved in the energy sector under local content provisions; legal and regulatory framework for the implementation of local content; challenges of enforcing local content provisions for both the investors and nationals; and way forward. Additionally, participants will acquire knowledge in the various investment and other opportunities that they can utilise under the local content provisions. We also employ a comparative analysis to discuss local content in various countries and what African countries can learn from advanced countries with respect to local content.

8. Training on Investment Dispute Resolution

This training focuses on the practicalities of Investment Arbitration. This hands-on training and open discussion will guide participants through the main stages of a typical arbitration institute including the Stockholm Chamber of Commerce (SCC) and the Permanent Court of Arbitration (PCA) investment arbitration process in a very practical way. The training covers complex area of determination of damages. Upon completion of the training, participants will gain knowledge and grasp a clear understanding, know how and skills necessary in order to help them face a typical investment arbitration process in a confident manner.

9. Masterclass Executive training on Mining

This is a four days training programme. The main aim of the class is to introduce participants to the main principles and concepts of law and regulations for mining; ownership and tenure; interface of mining and other land uses and environmental regulation. The training also explores relationship between law, investment and the contribution of mining to sustainable development. It takes on the perspective of domestic, regional and international standards. This training is suitable for anyone with an interest in expanding their understanding of natural resources law and regulation through the lenses of sustainable development; those interested in understanding the investment climate and opportunities in the mining sector.

Participants in this training will gain an understanding of the ownership and main regimes of access to mineral rights; international and comparative aspects; mining investment decisions especially for large scale mining; artisanal and small scale mining and the challenges and opportunities in this sector; investment and finance for large scale and small scale mining; key issues relating to formalisation and legalisation of artisanal and small-scale mining; land rights specifically access to land and indigenous people's rights with respect to the debate on consultation and free, prior and informed consent.


10. Masterclass Executive training on sustainability, climate change, social and economic impacts of the Extractive industries.

This three days course gives participants an understanding of the resource curse debate; corporate social responsibility; the concept of sustainable development and how it applies in the extractive industries focusing on the UN Sustainable Development Goals (SDGs); the role of good laws and institutions in promoting the contribution of the extractive industry to sustainable development; environmental standards specifically looking at mining closures and decommissioning of oil & gas installations. Participants will also acquire knowledge with respect to the current debate on climate change and its nexus to the extractive industries.

1. Dr. Victoria Nalule

She has also worked with both the private and public legal sectors of Uganda including Kakuru & Co. Advocates and the Anti-Corruption Court of Uganda.

by the EU Commission's Horizon 2020 program, most notably a grant of EUR14 million as part of a consortium of 21 institutions to work on renewable energy and smart grids Rafael is author of the books EU Trade Law (Elgar, 2019), Energy Security, Trade and the EU: Regional and International Perspectives (Edward Elgar, 2016), The European Energy Union: The quest for secure, affordable and sustainable energy (Claeys & Casteels Publishing, 2016), International Energy Governance: Selected Legal Issues (Edward Elgar, 2014), Climate Change and International Trade (Edward Elgar, 2013), International Trade and Investment Law: Multilateral, Regional and Bilateral Governance (Edward Elgar, 2010) and Theory and Practice of EC External Trade Law

and Policy (Cameron May, 2008) and the editor or co-editor of the Commentary on the Energy Charter Treaty (Edward Elgar, 2018), University Initiatives in Climate Change Mitigation and Adaptation (Springer, 2018), Research Handbook on EU energy law and policy (Edward Elgar, 2017).

He has served in the Sustainable Energy for All Secretariat (Washington, DC), the Energy Community Secretariat, the Energy Charter Secretariat, the World Trade Organization, and several EU institutions (EU Commission, EU Parliament, EU Council, EU Court of Justice). He is the author of more than 160 scholarly publications on international trade and WTO law, climate change law, energy

EU international governance. law, investment law and the interaction among them in American and European law reviews such as the Columbia Journal of European Law, Georgetown Environmental Law Review, University of Pennsylvania Journal of International Law, The George Washington International Law Review. Fordham International Law Journal. Chicago Journal of International Law, Legal Issues of Economic Integration, European Foreign Affairs Review, and Journal of World Energy Law and Business (Oxford University Press).

Rafael has been a Global Research Fellow at New York University School of Law (Hauser Global Law School Program); Visiting Fellow at the World Trade Institute; Visiting Scholar at Georgetown University Law Center: Scholar at Masdar Institute at Khalifa University (Abu Dhabi); Tillar House Resident Fellow at the American Society of International Law; Visiting Researcher at Harvard Law School and Fellow at the Real Colegio Complutense (Harvard University); Emile Noël Doctoral Fellow at New York University School of Law; Fellow at the Australian National University; and Visiting Scholar at the University of Wisconsin-Madison Law School.

He teaches International economic law; Trade, climate change and energy law; International trade and investment law; and EU external relations law. He received his graduate legal education at Stanford Law School, Columbia Law School, the London School of Economics and Political Science, and the European University Institute (Florence).
